**A BILL**

To amend the John D. Dingell, Jr. Conservation, Management, and Recreation Act to establish the Cerro de la Olla Wilderness in the Río Grande del Norte National Monument and to modify the boundary of the Río Grande del Norte National Monument.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cerro de la Olla Wil-  
5 derness Establishment Act”.

1 **SEC. 2. DESIGNATION OF CERRO DE LA OLLA WILDERNESS.**

2 (a) IN GENERAL.—Section 1202 of the John D. Din-  
3 gell, Jr. Conservation, Management, and Recreation Act  
4 (16 U.S.C. 1132 note; Public Law 116–9; 133 Stat. 651)  
5 is amended—

6 (1) in the section heading, by striking “**CERRO**  
7 **DEL YUTA AND RÍO SAN ANTONIO**” and inserting  
8 “**RÍO GRANDE DEL NORTE NATIONAL MONU-**  
9 **MENT**”;

10 (2) in subsection (a), by striking paragraph (1)  
11 and inserting the following:

12 “(1) MAP.—The term ‘map’ means—

13 “(A) for purposes of subparagraphs (A)  
14 and (B) of subsection (b)(1), the map entitled  
15 ‘Río Grande del Norte National Monument Pro-  
16 posed Wilderness Areas’ and dated July 28,  
17 2015; and

18 “(B) for purposes of subsection (b)(1)(C),  
19 the map entitled ‘Proposed Cerro de la Olla  
20 Wilderness and Río Grande del Norte National  
21 Monument Boundary’ and dated January 28,  
22 2021.”; and

23 (3) in subsection (b)—

24 (A) in paragraph (1), by adding at the end  
25 the following:

1           “(C) CERRO DE LA OLLA WILDERNESS.—  
2           Certain Federal land administered by the Bu-  
3           reau of Land Management in Taos County,  
4           New Mexico, comprising approximately 13,103  
5           acres as generally depicted on the map, which  
6           shall be known as the ‘Cerro de la Olla Wilder-  
7           ness’.”;

8           (B) in paragraph (7)—

9           (i) by striking “map and” each place  
10          it appears and inserting “maps and”; and

11          (ii) in subparagraph (B), by striking  
12          “the legal description and map” and in-  
13          serting “the maps or legal descriptions”;  
14          and

15          (C) by adding at the end the following:

16          “(12) WILDLIFE WATER DEVELOPMENT  
17          PROJECTS IN CERRO DE LA OLLA WILDERNESS.—

18          “(A) IN GENERAL.—Subject to subpara-  
19          graph (B) and in accordance with section 4(c)  
20          of the Wilderness Act (16 U.S.C. 1133(c)), the  
21          Secretary may authorize the maintenance of  
22          any structure or facility in existence on the date  
23          of enactment of this paragraph for wildlife  
24          water development projects (including guzzlers)

1 in the Cerro de la Olla Wilderness if, as deter-  
2 mined by the Secretary—

3 “(i) the structure or facility would en-  
4 hance wilderness values by promoting  
5 healthy, viable, and more naturally distrib-  
6 uted wildlife populations; and

7 “(ii) the visual impacts of the struc-  
8 ture or facility on the Cerro de la Olla Wil-  
9 derness can reasonably be minimized.

10 “(B) COOPERATIVE AGREEMENT.—Not  
11 later than 1 year after the date of enactment of  
12 this paragraph, the Secretary shall enter into a  
13 cooperative agreement with the State of New  
14 Mexico that specifies, subject to section 4(c) of  
15 the Wilderness Act (16 U.S.C. 1133(c)), the  
16 terms and conditions under which wildlife man-  
17 agement activities in the Cerro de la Olla Wil-  
18 derness may be carried out.”.

19 (b) CLERICAL AMENDMENT.—The table of contents  
20 for the John D. Dingell, Jr. Conservation, Management,  
21 and Recreation Act (Public Law 116–9; 133 Stat. 581)  
22 is amended by striking the item relating to section 1202  
23 and inserting the following:

“Sec. 1202. Río Grande del Norte National Monument Wilderness Areas.”.

1 **SEC. 3. RÍO GRANDE DEL NORTE NATIONAL MONUMENT**  
2 **BOUNDARY MODIFICATION.**

3 The boundary of the Río Grande del Norte National  
4 Monument in the State of New Mexico is modified, as de-  
5 picted on the map entitled “Proposed Cerro de la Olla Wil-  
6 derness and Río Grande del Norte National Monument  
7 Boundary” and dated January 28, 2021.
